Less common symptoms:

diarrhoea
conjunctivitis
headache
loss of taste or smell
a rash on skin, or discolouration of fingers or toes

- I understand the above symptoms and affirm that I, as well as all household members and people that I have been in contact with, do not currently have, nor have experienced the symptoms listed above WITHIN THE LAST 14 DAYS.
- I affirm that I, as well as all household members, have not been diagnosed with COVID-19 WITHIN THE PAST 30 DAYS.
- I affirm that I, as well as all household members, have not knowingly been exposed to anyone diagnosed with COVID-19 WITHIN THE PAST 30 DAYS.
- I affirm that I, as well as all household members, have not travelled outside of the country, or to any city considered to be a "hot spot" for COVID-19 infections WITHIN THE PAST 30 DAYS.
- I understand that Luscious Inc (Lashes, Brows, Tanning) cannot be held liable for any exposure to the COVID-19 virus caused by misinformation on this form or the health history provided by each client.

Luscious Inc. are following these enhanced procedures to prevent the spread of COVID-19:

- Prepayment for services are to be contact-less checkout. You can EFT us the amount, and bring along proof of Payment.
- You will need to enter with a mask on, and wear it through the entire procedure. Failing this, you will be asked to reschedule.
- Disposable masks are available at R20.
- Additional time included between appointments to prevent client contact with each other.
- No guests are allowed to accompany clients during treatments or in the waiting area.
- Each client is required to wash and sanitize hands upon arrival.
- Your esthetician will thoroughly clean hands between each client, and dispose of disposables and sanitize the work area.
- Your esthetician will wear a mask for every client
- All products used during treatment will be placed on the trolley for disinfection and disposable items will be used when possible
- All surfaces will be wiped thoroughly with hospital grade disinfectant before and after each client according to the manufacturer's directions
